## JinkoSolar Attends B20 Summit in Hangzhou

HANGZHOU, China, Sept. 2, 2016 /PRNewswire/ -- JinkoSolar Holding Co., Ltd. ("JinkoSolar" or the "Company") (NYSE: JKS), a global leader in the photovoltaic (PV) industry, today announced that it has been invited to attend The Business 20 (B20) Summit to be held in Hangzhou on September 3-4. As the only renewable energy company in Infrastructure taskforce, JinkoSolar have been working with other members in formulating policy recommendations for the Group of Twenty (G20) body in the area of infrastructure. The B20 summit will summarize these proposals and report the work results to G20.
